# 3.1 Superintendent's Report

#### SBA/Verizon Cell Tower

Verizon is anticipating delivery of the SBA/Verizon cell tower at Mayfair Park equipment (cabinet, antenna, and generator) will begin on October 2nd.

#### Garage Fire

IPARKS insurance adjuster was out earlier this week, the Fire Investigator is scheduled on October 6, 2017. After the investigation is been completed and the Park District receives clearance from the Insurance Investigator, the Police Chief and Fire Chief will discuss how to start the process of removal and replacement will begin. This is an active arson and crime investigation. President Martin explained fire investigations and stated he is not involved in the garage fire investigation.

# Mayfair Park Vitek Field Lighting

The lights were inspected on the East Field by Cellular Tower Company, once engineered the representative will make an appointment to come out to make the adjustments.

3.2 <u>Bid Results</u> - The Park District went out to bid on the dog park project and had a pre-bid meeting on September 28, 2017. Bids were opened today, October 2, 2017 at 11:00 A.M. The Commissioners discussed unallocated capital project funds for the Dog Park. There were no problems with the bid or the contractor. President Martin recommended adding the dog park bid approval on the October 9, 2017 agenda. Commissioner Busa asked Mr. Burg to research and report back on the chemical cost of running the pool on a day to day basis.
