Most importantly, remember that this is a voluntary recreational activity. Never compromise your safety in the name of competition.

Warning of Risk: Running and power walking are intended to challenge and engage the physical, mental, and emotional resources of each participant. However, despite careful and proper preparation, instruction, medical advice, conditioning, and equipment; there is still a risk of serious injury, including death. Understandably, not all hazards and dangers can be foreseen. The very nature of road racing is hazardous and risky, including but not limited to overexertion, dehydration, slip and falls, collision with other participants, the effects of weather, dangerous conditions of the road, being struck by a vehicle or bicycle, lack of good physical conditioning, poor training technique, and all other circumstances inherent in running/walking events. In this regard, it must be recognized that it is impossible for the Westchester Park District to guarantee absolute safety.

Waivers & Release of all Claims, Assumptions of Risk: Please read this form carefully and be aware that in signing up and participating in this event, you will be expressly assuming the risk of legal liability and waiving and releasing all claims of injuries, damages, or loss which you or your minor child/ward might sustain as a result of participating in any and all activities connected with and associated with this event. As a participant in the Hero Hustle 5K Run, I recognize and acknowledge that there are certain risks of physical injury, and I voluntarily agree to assume the full risk of any injuries, including death, damages, or loss, regardless of severity that my minor child/ward or I may sustain as a result of participating in any and all activities connected with or associated with this event.
