WESTCHESTER PARK DISTRICT
TRUTH IN TAXATION LAW RESOLUTION

BE IT RESOLVED, by the Board of Park Commissioners of the Westchester Park District, Cook County, Illinois ("Park District"), having reviewed the most current and reliable financial data, has made the following determinations as required under the "Truth in Taxation Law":

1. The total amount of real estate taxes extended by the Park District for the 2023 tax year (reflected in the 2024 tax bill), excluding costs related to election expenses, public building commission leases, and debt service levies, along with any amount abated by the Park District before extension, is hereby determined to be \$1,575,708.

2. The proposed amount of the real estate taxes to be levied by the Park District for the 2024 tax year (reflected in the 2025 tax bill), excluding election costs, public building commission leases, and debt service levies, is estimated to be \$1,653,500.

3. Based on the foregoing determinations, the estimated percentage change in the proposed 2024 aggregate levy over the 2023 aggregate levy extension is calculated as an increase of 4.94%. Consequently, it has been determined that, in accordance with the Truth in Taxation Law, neither a public hearing nor publication is required for this levy, given that the increase does not exceed the statutory thresholds mandating such actions.


