

ORDINANCE NO. 2024-5
**ORDINANCE LEVYING AND ASSESSING TAXES
FOR THE WESTCHESTER PARK DISTRICT,
COOK COUNTY, ILLINOIS, FOR THE
2024 TAX YEAR**

BE IT ORDAINED BY THE BOARD OF PARK COMMISSIONERS OF THE WESTCHESTER PARK DISTRICT, COOK COUNTY, ILLINOIS:

Section 1: Tax Levy Amount. The sum of One Million Six Hundred and Fifty-Three Thousand Five Hundred 00/100 Dollars (\$1,653,500.00), or so much thereof as may be authorized by law for the following purposes, is hereby levied and assessed against all taxable property within the limits of the Westchester Park District (the "District") at full, fair cash value as the same is assessed and equalized for state and county purposes for the 2024 tax year. This levy excludes amounts previously levied for the payment of bond indebtedness and associated interest.

Section 2: Fund Allocation: The specific amounts levied for each fund are detailed below under the column titled "Amount Levied". These amounts are deemed necessary by the Board of Commissioners of the District to defray the expenses and liabilities of the District for the fiscal year beginning **May 1, 2025**, and ending **April 30, 2026**.

Section 3: Budget and Appropriation. Pursuant to Section 4-4 of the Park District Code (70 ILCS 1215/4-4), neither the current fiscal year's Budget and Appropriation Ordinance of the District nor any other Budget and Appropriation Ordinance is required to support the tax levy made in this Ordinance.

Section 4 Use of Unexpended Funds: The unexpended balance of any funds levied under this Ordinance may be expended to offset deficits in other items within the same general appropriation and levy made by this Ordinance. Additionally, any unexpended balance of the tax levied for general corporate purposes from the preceding year may be accumulated and allocated to a capital improvement fund for building repairs and improvements, provided that the total balance of such a fund does not exceed 1.5% of

the aggregated assessed valuation of all taxable property within the District.

Section 5: The Secretary is hereby directed to file a certified copy of this Ordinance with the County Clerk of Cook County, within the timeframe specified by law. The County Clerk shall extend the tax to produce the amounts levied herein upon the books of the Collector of the State and County as required by law.

Section 6: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.


